**Stipulations**

The student-athlete and his or her parent/guardian have received and read the *Redeemer Lutheran School Athletic Handbook*. Based on this information, the student and parent/guardian understand and stipulate to the following:

1. I/We understand the eligibility regulations required for participation and affirm that all eligibility requirements have been satisfied, including age (WPIAL), medical (2015) and academics.
2. I/We affirm that the student will exert effort to maintain a high level of academic achievement.
3. I/We understand there is potential for serious, catastrophic, or life-threatening injury associated with participation in a sport.
4. I/We affirm that the student will not participate in poor sportsmanship, or inappropriate conduct of any nature – in/out of school, on/off the court or field, and instead demonstrate Christ-like behavior.
5. I/We, as parents will encourage my/our child to be compassionate and caring to their teammates, coaches, and opponents.
6. I/We, as a participant or spectator, will exhibit a high level of sportsmanship at contests.
7. I/We will follow appropriate procedures in communicating concerns to coaches.
8. I/We affirm that the student will abide by all team and participation standards.
9. I/We affirm that the student will not use steroids, illegal drugs, alcohol, and tobacco unless medically prescribed for a specific condition or illness an on record in the school office.
10. I/We understand that students will be transported by car to and from games.

11. I/We will submit payment for uniforms (prior to the first game) and other costs (as needed – gas, refs).

**Permission to Participate**

I/We hereby authorize and consent to our child's participation in interscholastic athletics and sports at Redeemer Lutheran School.

We understand that the sport in which our child will be participating is potentially dangerous, and that physical injuries may occur to our child requiring emergency medical care and treatment. I/We assume the risk of injury to our child that may occur in an athletic activity.
